**Rental History**

All Rental History must be verifiable and favorable

**Income Requirements**

Applicant(s) must have verifiable income of at least two and a half times monthly rent. Prior to approval of application applicant must provide documents such as, Pay stubs covering two periods, court ordered spousal or child support, pensions, or prior year's W-2.

If unemployed or retired, proof of income / assets must be provided and must be equal to two and a half times the contractual amount of the lease term.

**Credit History**

All applications are subject to processing through the designated agency or associate of our choice.

**No more than 10% negative accounts**

No Current Collections or past due balances/delinquencies

No Bankruptcies within 5 years. Bankruptcies 6 years and older, credit report must reflect only positive payment history thereafter

No Public Records (such as, but not limited to; Tax Liens or Court Judgments)
