3 EASY STEPS... TO MAKE CONCORD SQUARE APARTMENTS YOUR NEW HOME

STEP #1:

To hold one of our apartment homes, you will need the following:

- A non-refundable application fee of \$40.00 (\$120.00 max for 3 applicants or more) in a personal check, money order, or credit card payable to Concord Square Apartments.
- A personal check, money order, or credit card payment for \$350.00 payable to "Concord Square Apartments" we will hold your new home for 3 days (72 hours).
- Completed application(s).
- Driver's license/government issued I.D. card with photo.
- I.D. showing Social Security number.
- Two most recent pay stubs w/year to date, or last year's tax return.
- If self-employed, copies of last year tax returns.
- Income Requirement - Gross Income is a minimum of 3 times the Rent.

STEP #2:

After 72 hours, and/or when your application approval has been given, we will deposit your personal check, and/or money order for the \$350.00.

The \$350.00 will be credited to your security deposit account and will now reserve your new home for an additional 14 days.

STEP #3:

Upon your move-in date (and in order to obtain the keys to your new home) the following will be required:

- Your signed lease agreement
- The balance of your security deposit *
- The first month's rent *
- Registered on the Pay-Lease System
- Electricity account number provided by the Department of Water and Power

- Proof of Renter's Insurance for your new home showing the required amounts of \$20,000 personal property and \$100,000 liability.

**Security deposit balance and first month rent must be in the form of a certified cashier's check or money order only.*



Application, Lease Terms and Qualifications

APPLICATION:

- A \$40 application fee is required to cover the cost of reviewing credit and rental history.
- The application must be accompanied by a deposit check. A \$350.00 deposit check is required to hold the apartment.
- All paperwork must be turned in within 3 days, or the apartment will be cancelled.

LEASE TERMS:

- Lease terms are 12 months.

QUALIFICATIONS:

- Monthly gross income equal to 3 times the rent (all income must be verifiable)
- Employment verification
- Satisfactory credit history
- Satisfactory rental history
- Photo ID
- Valid driver's license
- Renter's Insurance Policy is required at the time of move-in.
